INFORMED CONSENT – JUNIOR PARTICIPANTS

WARNING - BY SIGNING THIS FORM, YOU GIVE UP THE RIGHT TO SUE FOR DAMAGES

In consideration of the Lotus Sports Club ("Lotus") accepting the application for, and my child being permitted to participate in club activities organized by the Lotus Sports Club ("LOTUS Activities"), I agree to this release of claims, waiver of liability and assumption of risk (collectively, this Agreement).

I acknowledge that the enjoyment and excitement of Lotus Activities is derived, in part, from the inherent risks associated with such activities beyond the accepted safety of life at home or work and that these inherent risks contribute to such enjoyment and excitement, being a reason for my child's participation.

I accept all the inherent risks of the Lotus Activities and the possibility of personal injury, death, property damage or loss resulting there from and still wish to give consent because of the value of participation in these activities to my child.

I am aware that Lotus Activities, in addition to usual dangers and risks associated with outdoor recreation activities, have certain additional inherent dangers and risks some of which may include but are not limited to:

- physical exertion for which my child may not be prepared;
- weather extremes subject to sudden and unexpected change;
- dangerous waters including rapids, white water and cold waters;
- collision with other boats including other race boats as well as commercial boat traffic or pleasure boats;

I waive any and all claims I may now and in the future have against and release from all liability and agree not to sue or allow executors, heirs or insurers to sue Lotus Sports Club and its officers, members, employees, guides, coaches, volunteers, agents, sponsors, or representative (collectively its staff) for any personal injury, death, property damage, or loss sustained by me as a result of my child's participation in Lotus Activities due to any cause whatsoever, including without limitation, negligence on the part of Lotus Sports Club or its staff.

I acknowledge that I can, if I wish, purchase personal accident insurance to compensate me or my heirs for any personal injury, death, property damage, or loss sustained as a result of my child's participation in any Lotus Activity.

NOTE: Junior participants (under 19 years of age on date of event) require written consent of parent or legal guardian capable of giving consent - NO EXCEPTIONS.
